ORDER

No.F.12(3)FD/(Rules)/2008

Jaipur, dated : 01 MAY 2012

**Subject :-** Revision of pension of Government servants who retired during the period from 01.09.2006 to 31.05.2009 and were drawing Special Allowance on the date of retirement.

Under Rule 8 of the Rajasthan Civil Services (Revised Pay) Rules, 2008 existing Special Pay was converted into Special Allowance w.e.f. 01.09.2006. This Special Allowance has again been converted into Special Pay w.e.f. 01.06.2009 vide FD Notification No.F.14(92)FD/Rules/2008 dated 23.07.2009.

Government servants who have retired during the period from 01.09.2006 to 31.05.2009 and who have drawn Special Allowance immediately before their retirement is not countable as emoluments under Rule 45 of Rajasthan Civil Services (Pension) Rules, 1996 for calculation of retiral benefits. Thus, these employees have deprived of enhanced pension on account of conversion of Special Pay into Special Allowance which is recurring loss to them.

Accordingly, the matter has been considered and the Governor is pleased to order that those Government servants who retired during the period from 01.09.2006 to 31.05.2009 and who were drawing Special Allowance immediately before the date of their retirement, the Special Allowance so drawn shall be treated as Special Pay as an exception for determination of emoluments for the purpose of calculation of pension under Rule 45 of Rajasthan Civil Services (Pension) Rules, 1996. Only pension shall be revised from the date of issue of this order and no arrear of pension shall be payable. It is made clear that revision of DCRG, Commutation of pension and Encashment of balance of Leave shall not be permissible.
